## From GLITC Leadership

August 2021

The past 17 months have been challenging for our Great Lakes Inter-Tribal Council (GLITC) employees and facility. The COVID-19 pandemic required leadership and our custodial staff to look closely at our policies, procedures, and practices to prevent the spread of COVID-19 and to keep all employees safe. With guidance and support from Lac du Flambeau Tribal leadership, CEO Bryan Bainbridge, and the custodial staff, GLITC implemented a rigorous process to prevent exposure.

Many initiatives were put in place. Custodian Janet Wink oversaw regular deep cleaning that included sanitizing the entire building, cleaning our bathrooms 2 to 3 times per day, checking that kitchen cleanliness processes were followed, cleaning rooms after staff use, and researching and buying personal protective equipment for employee and visitor use.

GLITC installed locking lobby doors and distributed employee access fobs to control traffic flow in the building. One-way traffic was instituted throughout the facility, thus eliminating cross-traffic and close encounters with employees and creating good social distancing.

All food exchange was eliminated, and no food was stored in the facility. Refrigerator rules directed employees to only bring food that would be consumed that same day. The kitchen was closed permanently except for the microwave, which had “use at your own risk” and “clean after use” policies.

Our custodian, Janet Wink, deserves much of the credit for keeping our facility clean, safe, and secure. Our facility returned to a full-staffing model June 1, 2021. We are so grateful for all the support and efforts.

# GLITC and COVID-19 Vaccines: Helping a Tribal Community at Ground Level

In late December 2020, as COVID-19 vaccines were being approved and shipped to Tribal communities, Amy Poupart, who is a member of the Lac du Flambeau Tribal Health Board and is the Program Director for the Great Lakes Native American Research Center for Health (Great Lakes NARCH), reached out to the Peter Christensen Health Center (PCHC) in Lac du Flambeau. The question she asked was if the clinic had enough available staff to implement the phased rollout of vaccines, as the pandemic shutdowns had stressed the healthcare delivery systems. After getting approval from GLITC CEO, Bryan Bainbridge, assistance was offered to PCHC in the form of a few GLITC staff members.

Initially, Melissa Doud, Program Director for the Wisconsin Native American Tobacco Network (WNATN) and Lac du Flambeau Tribal Council member, and Amy were tasked with performing health status screenings, which were required for entrance into the COVID-19 vaccine clinics. These screenings included taking temperatures, asking screening questions, providing consent forms for completion, and sanitizing pens, clipboards, and any other materials contacted by patients.

As discussions with the Community Health Department occurred, it became evident GLITC staff were a group that should be considered a higher potential exposure status because many of them travel in and out of the Lac du Flambeau community since most live adjacent to the reservation. Amy advocated that the GLITC employees be offered the vaccine similar to the manner in which other Tribal entities were being offered. Melissa supported this, and the Community Health Department agreed. At the end of February, with other priority health groups' vaccinations completed, PCHC was able to offer the vaccine to interested GLITC employees.

This effort enabled 30 employees to get their two COVID-19 vaccine doses. This greatly assisted in the process of reopening our GLITC office as Tribal resolutions were lifted. Various GLITC staff were also able to help with continued vaccination efforts up to the beginning of May, as vaccinations became more readily available to the general public. In all, more than 25 vaccine clinics of both first and second doses were assisted by GLITC staff. Unfortunately, due to understandable travel restrictions, GLITC staff could not travel to other Tribal communities to assist in a similar way.
